Both tests were for 25 Markers. The results from Family Tree DNA of Gerald Q. Nash were as follows: "A high resolution match has been found between you and another person (Archie Nash) in the Family Tree DNA database. You and the other person have matched in 23, 24, or 25 loci, which means, that there is a 99.9% likelihood you have a common ancestor." This common ancestor is Joseph Nash [172.II], p. 87, father of Shubael and Zenas Nash.

- [2555.31] Margaret Wilna Nash. New material regarding her is as follows. She was b. 31 Aug 1909, Osco Twp., Ill.; d. 25 Sep 2001, Arizona; bur. 12 Oct 2001, Grace Church Cem., Osco. She was a nurse. She m. (1) *Martin Doehler*, in September, 1946. He was b. in 1892 and d. 2 May 1964. She m. (2) on 30 Dec 1977, at River Forest, Ill., *Alfred M. Swanson*. - 1436 [2769.521] Patricia Susan Nash. Delete "...(son of...." at the end of the last line on the
